Hope this letter finds everyone in good spirits and health. We also hope your 2009 racing season was a successful one!

We have scheduled the Show for Friday May 28th from 2:00 to 8:00pm and Saturday, May 29th from 9:30am to 5:00pm. Voluntary set-up will be on Thursday May 27th from 4:00pm to 7:00pm, with additional set up time on Friday May 28th from 10:30am to 1:30pm. The drive-to-your-table unloading option will only be available for those setting up on Thursday, May 27th.

IMPORTANT: To avoid problems that we encountered in 2009. Until December 15, 2009, only those who had wall tables at the 2009 Show can reserve wall tables for the 2010 Show. If you did not have a wall table in 2009, but would like one in 2010, execute your Application and attach a note indicating that you would like a location change for 2010. If available, we will contact you to confirm availability. For those dealers who want to keep their exact location from last years show, we must have your executed contract and payment by December 15, 2009. Early indications from several of our dealers who are requesting additional space indicates that we will once again be 'challenged' for space in 2010. Several familiar faces who were not with us last year will also be back in 2010.

Despite incurring price increases from the Indiana State Fairgrounds, we will keep table fees at the 2003-2009 level.

We are anticipating a very impressive autograph guest lineup for 2010. We anticipate a strong Hoosier Hundred turnout for 2010.

NATIONAL AUTO RACING MEMORABILIA SHOW RULES AND POLICIES

1. This application is subject to the approval of the National Auto Racing Memorabilia Show, LLC, hereafter referred to as "The Show" and by submitting this application, the applicant and their authorized exhibitors agree to abide by the terms stated herein and the policies of The Show applicant cannot assign, sublet or otherwise transfer any rights or privileges granted hereunder. Also, the applicant agrees not to lease, sublease or share tables. The Show reserves the right to resell any tables not occupied by the applicant.
2. Anyone who is found "soliciting" material in the lobby, parking lot, or otherwise on the premises of the convention, will be required to close his table and leave the premises, without refund.
3. The Show assumes no responsibility for any loss, theft, or injury suffered by throughout the convention, including set-up and break-down time.
4. Refunds will not be made on table cancellations unless the table/booth is resold by The Show. No refunds will be made on any cancellations made during thirty (30) calendar days immediately prior to the event. The Show will not be liable for refunds on tables/booths due to the cancellation of the event for reasons not caused by The Show.
5. The names of all people who will assist the dealer must be on record with The Show, PRIOR to the event dates. The Show will permit only dealers of record for this show, to sell inside or outside The Show facility. Anyone found illegally selling will be subject to removal from the property and /or prosecution. We reserve the right to deny access to anyone deemed undesirable to the good of the show.
6. Any form of solicitation for shows other than The Show sponsored events will not be permitted inside or outside The Show facility without prior written approval of The Show. Violators are subject to the removal from the property and the confiscation of printed material contrary to this policy.
7. Table/booth reservation entitles the dealer to two (2) free badges. However, The Show will provide only the number of admission badges corresponding to the names of table assistants on record with The Show. All other members of the dealer's party are expected to purchase a badge or admission ticket. Dealer receives one additional badge for every subsequent tables purchased.
8. Anyone selling or trading reprinted material, not clearly marked as such, or dealing in counterfeit or stolen merchandise, will be subject to removal from the show facility, confiscation of said material, and the fullest prosecution of the law.
9. Dealers are expected to dress and conduct themselves in a manner that reflects in a positive manner on this show, the general public, fellow dealers and this hobby/industry. Dealers are expected to be neatly dressed and groomed. Dealers are expected to keep their table area neat and free of trash and refuse. Offensive language is not permitted. Violation of any rules may be cause for the immediate removal of the offender from the show facility without prior warning or refund.
- 10 The Show reserves the right to deny a table rental to any individual without providing a reason for the denial.
- 11 The Show reserves the right to set additional rules and policies for the show that it deems proper and necessary, the dealer agrees to accept the interpretation of all rules and policies set forth by The Show.
12. The terms specified on this form are considered to be a contractual agreement between the registered dealer and The Show. The Dealer through submission of this application, and payment for his exhibit space, agrees to abide by all show rules, policies and procedures and to accept the responsibility for the compliance of same by all members of his party throughout the duration of the show.
13. Exhibitor agrees to assume all responsibility for and comply with all applicable Federal and State of Indiana tax regulations.
14. The Show reserves the right to cancel table privileges to a table holder who displays dishonest or immoral character, such as, unresolved customer complaints, bad checks, altered memorabilia, etc..
15. Management/ownership of The Show is the sole entity responsible for assigning exhibitors to specific tables/booths within The Show.
16. Exhibitors are not allowed to bring tables in to the show area.
